I will take this responsibility seriously and if any area of my life is in contradiction to FBC's teachings and beliefs, I will immediately notify the appropriate leader or staff person and after discussion, (if necessary), step down from my responsibilities with children until those issues are resolved.
- I will support and encourage the vision of the church and its leadership. I will seek to preserve unity in the Body by supporting church leaders in prayer. If I have any concerns or issues, I will address my concern to the pastor over my area of ministry.
- It is the desire of the leadership at FBC that every *teacher* who teaches at Faith be in agreement with, and consent to support, the doctrinal position as stated in our Doctrinal Statement. Your signature will assure the leadership that you consent to the Doctrinal Statement in what you believe and teach (where applicable).

- b. Faith Bible Church of DeSoto, TX may do further checks on my personal background and driving record. I release Faith Bible Church from any liability for doing such a check.
